Making the 2014 Minneapolis Meeting

The program for the 2014 AAEA Meeting is in your making! The calls for invited paper proposals, selected presentation abstracts, case

studies, pre- and post-conferences, frontier sessions, and organized symposia are <u>out</u>. The Sections are very actively putting together their tracks. Sharing your research, teaching, and extension is at the heart of our meetings.

I want to bring two areas of our 2014 meeting program to your particular attention:

Invited Papers. For the 2014 meeting we have one invited session that features case studies organized by the Case Study Committee (Peter Stenberg, Michael Boland, Conrad Lyford, and Fabio Chaddad) and six invited paper sessions. The Program Committee (Keith Coble, Scott Swinton, and me) welcome your innovative and provocative invited paper proposals. Invited papers may take formats that advance understanding and share emerging knowledge on topics in agricultural and applied economics likely to define future research agendas, such as broader thought-pieces or syntheses of literature. They may also present related or complementary research papers. In all cases, we are looking for sessions that will be talked about and have an impact on the profession. Case studies and invited papers are posted on AgEcon Search and are very much encouraged to be submitted to the AJAE where they go through an expedited peer-review process for consideration for publication. We look forward to your proposals—please send me an email (caswell@umass.edu) or give me a call (413) 545-5735 if you would like to discuss your ideas.

Posters. Posters are an excellent way to present your work and get feedback in an interactive, informal atmosphere. The creativity and attention to communication that go into poster design often enhance the work itself. Our DC meeting in 2013 featured a record number of posters at 248; however, many presenters found that the meeting format, which did not feature dedicated attended poster times, left quite a bit to be desired in terms of generating feedback and connections to other attendees. For Minneapolis, we are working on a format that will feature posters on all three days of the meeting (Sunday, Monday, and Tuesday) offering poster presenters focused times to attend their posters and get great feedback from meeting participants. The Selected Presentations submission allows you to specify that you want your work considered as a poster or as either a selected paper/ poster. In DC, four Sections experimented with including posters as part of their tracks with great success. We are again offering Sections the opportunity to submit posters and poster tours as part of their tracks. I'm looking forward to a great poster atmosphere in Minneapolis.

Call for Nominations: 2014 AAEA Awards

The AAEA Awards Program recognizes excellence in the work of agricultural and applied economists. The Awards Committee, chaired by Jeffrey Dorfman of the University of Georgia, welcomes nominations for all award categories. Specific details on the criteria used to judge each award, as well as instructions on how to submit nominations for the award are available below.

The selection process for each award is administered by a subcommittee. The chairperson of each subcommittee receives all nominations and administers the review process. The chairperson will eliminate any conflicts of interest with members of the subcommittee during the evaluation process.

The deadline for nominations is **February 3, 2014**. All nomination materials shall be submitted via e-mail as a PDF file to the AAEA business office at info@aaea.org.

Restrictions

Except for the Publication of Enduring Quality Award, only one AAEA award can be received for essentially the same work. It is the nominator's responsibility to assure that no AAEA award (other than Master's thesis or PhD dissertation award) has already been received for the nominated work. Should a nomination be selected for more than one award in the same year (e.g. Journal Article and Research Discovery), the awardee(s) will be permitted to choose which award is received.

No member of the executive board—elected, appointed, or ex-officio—is eligible to participate as a principal recipient in competition for awards. The exclusion does not preclude participation if (s)he is a junior participant with respect to other(s) for whom exclusion from participation clearly would be a handicap.

The purpose of this symposium is to provide a forum for presenting studies on the economics of food production and choice in a world in which social media and social networks have assumed a prominent role. The objective is to promote a better understanding of peer group influence on food consumption, and how social media and social networking affect food production and food choice decisions. Recognizing the role of social media in the broader food environment can help explain food choices that lead to unhealthy diets or the consumption of unsafe food. Understanding social media and social learning will help inform policies that use social concepts to control these, and other, food-related problems.

Choices, including those around health (diet quality), location (restaurant versus home), and ethical production decisions (animal welfare), can influence change in supply chains. Understanding the role of important determinants in production and consumption decisions can enhance efficiency and improve welfare. Peer effects, social media, and social networking represent only a few of the many factors that influence consumer choices, but how they interact with others in the broader economic context of food choices has been largely unexplored.

The symposium invites an international scientific audience in the fields of agricultural and food economics, agribusiness, behavioral and health economics, marketing, and related disciplines. Participants who would like to present a paper or poster are requested to submit an extended abstract in English (max. 2 pages; Times New Roman font, point size 12, single spacing) before *December 2, 2013* via our website. The abstract should indicate: the question addressed, the concepts and theories to which one refers, the methodology used and the results obtained. Notification of acceptance or rejection will be communicated by *January 31, 2014*. The deadline for the submission of the full version of the accepted papers is *April 3, 2014*. A selection of contributed papers will be published in a special issue of the *Canadian Journal of Agricultural Economics*.

The symposium will be held in beautiful and historic Montreal, Canada, on May 29-30, 2014. Seminar participants will be able to sample the finest in regional Canadian cuisine, participate in one of the many festivals offered year-round in Montreal, and visit some of the most important cultural attractions in Canada. AJAE Editor Update AJAE's Scholarly Metrics – Beyond Impact Factor

Much ado was made of the recently released ISI/Thompson Reuters metrics for indexed scholarly journals. These metrics are used increasingly by administrators to assess scholarly quality, award promotions and allocate scarce institutional resources. One metric in particular, the 2 year Impact Factor, has gained favor among administrators who frequently deal with natural sciences, where publication lags are brief. The 2012 Impact Factor, for example, is calculated as follows:

of citations during 2012 to articles published in the AJAE during 2010 and 2011

of qualifying articles published in AJAE during 2010 and 2011.

Larger impact factors are considered an indicator of scholarly quality as the 'average' article during the two year time period is generating more citations in the chosen year. There is also a 5-year version, where the years 2007 – 2011 replace 2010 and 2011. ISI/Thompson Reuters also issue several other annual metrics, including total citations, half-life, immediacy index, article influence and a quality-weighted eigenscore metric.

Compared to natural science fields, many social science journals generate lower Impact Factors due to longer publication lags. Furthermore, among AJAE's ISI category (Agricultural Economics and Policy), which features 17 total journals, and among other key journal competitors (Land Economics, JEEM), we are one of the few that has published proceedings papers (i.e., invited papers). For the purposes of Impact Factor, these 40 or so papers each year add substantially to the Impact Factor's denominator. In many years, however, these invited papers don't generate many citations.

In 2012, AJAE had a 2-year Impact Factor of 0.99, which ranks 7th in the Agricultural Economics and Policy category behind Food Policy (2.21), ERAE (1.85), AEPP (1.62), J. Agricultural Economics (1.50), Australian J. of Ag. & Res. Econ. (1.41) and Agr. Econ. (1.03). For perspective, in 2012, the American Economic Journal – Applied Economics, AEA's newly created second-tier journal, ranked 7th among all 2-year Impact Factors in Economics with an Impact Factor of 3.54 while the American Economic Review ranked 20th with a 2-year Impact Factor of 2.79. We doubt that few economists will now submit top ideas to AEJ-Applied Economics before turning to AER. However, due to a lack of perspective by authors outside traditional departments of Agricultural and Resource Economics and due to institutional emphasis on Impact Factor, we fear the same might not be true of the AJAE.

When one considers the various measures and metrics of scholarly quality for the AJAE, rankings emerge. For example, the AJAE's market share of 2012 citations among all journals of Agricultural Economics and Policy Journals was 41% (Table 1), which is nearly three times the market share of the next closest journal. When we expand this list to include the top six environmental and resource economics titles, we still retain a 14% market share, second only to Ecological Economics, which relies upon its heavy citations from scientific journals (Table 2).

Indeed, when all of ISI/Thomson Reuters Quality Metrics are considered (Table 3), AJAE fares poorly only in the metrics involving Impact Factor or transformations of the Impact Factor (e.g., article influence), while faring very well in metrics that deal with total impact and quality adjusted impact (cited half life, eigenfactor score). In terms of total impact, AJAE generated 1% of all economics citations in 2012, ranking it 20th among all economics journals, just behind the Journal of Banking and Finance and just ahead of Economics Letters. As for quality adjustment, AJAE's dominance with the Agricultural Economics and Policy category makes sense, as few other journals in this category were being cited by *Econometrica*, AER, REStat, JET, PNAS and Science in 2012. If colleagues or administrators need guidance on this discussion of journal quality, feel free to share these figures with them and help them put Impact Factor and AJAE's record in proper perspective.

Call for Applications Editor of Choices Magazine

The AAEA Board now seeks applications for one editor of *Choices Magazine* to be appointed for a four-year term, beginning in January 2015. This term runs from January 1, 2015—December 31, 2018; however, appointment extensions and/or renewals may be considered. Editorship appointments for *Choices Magazine* are staggered such that one new appointment is made every two years. The degree to which candidate's expertise complements that of the continuing editor, Mary Ahearn, will be considered in the selection process.

Choices is an online peer-reviewed magazine published by the AAEA for readers interested in the policy and management of agriculture, the food industry, natural resources, rural communities, and the environment. Issues are published twice quarterly and include theme articles and submitted articles.

The new *Choices* editor will work with the continuing editor to manage all submitted articles and to develop and coordinate theme proposals for *Choices*. The editors also provide leadership, coordination, and oversight of all aspects of publishing in conjunction with the AAEA Business Office. Once a new editor is selected, the editors will divide the editorial responsibilities as appropriate.

The new editor should be prepared to begin January 1, 2015. Applications should include a statement of editorial philosophy and ideas for furthering the publication's goals, a curriculum vitae, and a statement of support from the applicant's host institution. AAEA will provide financial assistance to defray some portion of the editor's time and expenses. According to AAEA policies, all editors must maintain current AAEA membership while serving as an editor.

SCC-76 Conference "Economics and Management of Risks in Agriculture and Natural Resources"

The 2014 Annual Meeting of the SCC-76 "Economics and Management of Risks in Agriculture and Natural Resources" Group will tentatively be held from March 27-29, 2014 at the Hilton in Pensacola, Florida.

The objective of the conference is to provide a forum to facilitate the exchange of applied approaches to risk analysis, economics, and policy--both empirical and theoretical--as well as to nurture the development and application of dynamic and original research efforts related to agriculture and natural resources. ERS Productivity Accounts Review

The USDA Economic Research Service has convened an external committee of Spiro Stefanou, Lilyan Fulginiti, Barbara Fraumeni, Jon Samuels, and Richard Shumway (chair) to review the ERS productivity accounts. This is the first comprehensive review these accounts have received since the joint AAEA-ERS review chaired by Bruce Gardner in 1978 that led to a major overhaul in the procedures used to develop the accounts. The committee has been charged to address issues of methodology in the development of estimates, ongoing research programs to improve methodology and operations, documentation and reporting of methods and uses of the data, and the frequency and timeliness of reporting.

One of their charges is to seek stakeholder input. The committee would appreciate input from the AAEA membership concerning such questions as the following:

- How are the national and state ERS productivity accounts being used?
- Do you use the national and/or state ERS productivity accounts?
- If so, how do you use them?
- What are the most important features of these accounts?
- Do you have questions about the methodology of their construction?
- Are you satisfied with the manner in which they are communicated?
- Is there additional information about the productivity accounts you would like to have provided online?
- Are there ways to make access to the accounts more convenient?
- Are you satisfied with the timeliness with which the productivity accounts are posted?
- Do you have recommendations for improving the quality of the productivity accounts or the effectiveness of their use?

22nd Annual Short Course in Global Trade Analysis "Introduction to Applied General Equilibrium Analysis in a Multi-Region Framework"

August 2-8, 2014 | West Lafayette, IN, USA

The 22nd Annual Short Course in Global Trade Analysis is being organized and hosted by the Center for Global Trade Analysis at Purdue University.

The objectives of this course are to introduce participants to a standardized framework for conducting global trade analysis in an applied general equilibrium setting, provide hands-on training with software that has been tailored to global trade analysis and give participants the opportunity to interact with economists working on global trade and resource use issues while becoming part of an international network.

The course will consist of two parts:

Part I: Web-based Modules (May 19 – July 20, 2014)

Part I is a series of modules delivered online. By working through this material in advance of the on-site course, participants will become familiar with the theory behind GTAP, the standard GTAP notation as well as the course software.

Part II: On-site intensive training (August 2-8, 2014)

Part II is an intensive, onsite short course consisting of a mix of daily lectures, lab assignments, and informal discussions designed to introduce participants to the basic features of the model and data base. These activities culminate in a major application based on one of the many extensions of the

GTAP Model undertaken by small groups and presented on the final day of the course. Each group is assigned two instructors who are intimately familiar with their project to act as resource persons. Participants leave with the capability of designing, conducting, and analyzing their own simulations.

Applications for this course are currently being accepted on the GTAP website through February 16. Applications will be reviewed as they are submitted. Demand for this course is very high; therefore, we strongly encourage early application. Please note that application does not guarantee acceptance.

The Implications of Hydraulic Fracturing for Creating Sustainable Communities

SUNY Conversations in the Disciplines

April 10 -11, 2014 • Binghamton University

Call for Proposals

The Conversations in the Disciplines (SUNY CID) grant program is designed to bring together SUNY faculty and visiting scholars from non-SUNY institutions to examine new trends, address changes and challenges, review promising research findings, and become acquainted with professional developments in their fields and on other campuses.

The advent of new hydraulic fracturing (aka hydrofracking or just fracking) technologies for natural gas development has required many communities across the United States to wrestle with challenging scientific, managerial, and political issues as they try to manage the local impacts the industry generates. Whether or not the State of New York lifts its current moratorium on drilling, these issues command public attention and demand policy outcomes that enhance the well-being of the residents who are most directly affected. The goal of the CID is to provide a forum for clarifying what we currently know about the impacts of the industry on local communities, and to develop interdisciplinary research agendas that address the most pressing questions that remain. An outcome of the conference will be an edited volume and/or on-line materials that will disseminate the participants' essential findings to a wider audience.

Binghamton University is seeking proposals for individual presentations on the implications of hydraulic fracturing at the community level. Please note that the purpose of this CID is not to either promote or discourage hydraulic fracturing but to understand the impacts, both positive and negative, and provide communities with the knowledge and tools that they need to decide what is in their own best interest.

Presentations should be 15-20 minutes each. In addition to presentations, conference organizers will provide additional scholars with opportunities to share their research and projects in a poster session. The purposes of this conference are:

- Identify what is known about the community impacts of hydraulic fracturing including the economic, environmental, health, and social conditions of the communities in which it occurs.
- 2) Identify strategies that communities have used to respond to hydraulic fracturing including ways to increase the economic benefits while minimizing any negative costs to the environment, health of community members, or social conditions.

- 3)Identify gaps in knowledge regarding community impacts of hydraulic fracturing and establish interdisciplinary research collaborations to address these gaps.
- 4) Identify gaps in knowledge regarding strategies that communities have used to respond to hydraulic fracturing and establish interdisciplinary research collaborations to address these gaps.
- 5) Publish the best papers from the Conversation in an edited volume.

NAREA Call for Workshop Papers Unconventional Gas and Oil Development: Economic and Environmental Impacts

Abstract Deadline: February 14, 2014

The 2014 Northeastern Agricultural and Resource Economics Association (NAREA) Workshop on Unconventional Shale Gas and Oil Development will be held at the Waterfront Place Hotel in Morgantown, West Virginia immediately after the NAREA Annual Meeting. The NAREA Workshop will take place on June 4-5, after the Annual Meeting on June 1-3. The Workshop may be attended either alone or in combination with the NAREA Annual Meeting.

The workshop will include addresses from recognized experts in the field, selected paper presentations chosen on the basis of submitted abstracts, and in-depth working sessions. A special issue of the Agricultural and Resource Economics Review (ARER) will be published from workshop papers accepted after an expedited version of the journal's peer-review process. Based upon available funding, the Workshop Committee anticipates providing a stipend to the presenting author of all selected papers.

Topics for Selected Papers

According to a recent International Energy Agency report, natural gas is poised to enter a golden age as a significant portion of the world's vast resources of unconventional gas are developed profitably and in an environmentally acceptable manner. The huge U.S. boom in shale gas development has been made possible to two principal technologies: horizontal drilling and high-volume, hydraulic fracturing. Despite the boon of these newly discovered energy resources, there are public fears over contamination of drinking water sources due to the chemical contents in hydraulic fracturing fluid. Until recently unconventional oil and gas development has received relatively little attention among applied economists. This Workshop will bring together researchers examining a broad range of economic and environmental issues surrounding the phenomena of unconventional fossil fuel development as a way to broaden our understanding of the key concerns facing land owners, government regulators, and private industry. In addition, analyses of economic issues facing different

types of unconventional energy development are expected to have wider applications across disciplines. The Workshop Planning Committee is particularly interested in cutting-edge economic research with issues that are relevant to unconventional gas and oil development. The goal of the 2014 NA-REA Workshop on Unconventional Shale Gas and Oil Development is to convene recognized and emerging experts to debate and advance research on the contemporary economic problems in energy, resource, and agricultural economics, with an emphasis on the development of policies that address economic development, sustainablility, environment, human health considerations, and climate change.

The workshop committee is seeking papers that advance the frontiers of economic analysis related to unconventional gas and oil development and policy issues. This includes papers from cutting-edge economic science and related fields that provide (1) novel methods for exploring economic impacts, (2) evaluate environmental impacts and risks, (3) develop and evaluate mechanisms for policies that aim to influence future unconventional fossil fuel development in the United States, and/or (4) otherwise address the role of unconventional gas and oil in the development of sustainable energy systems and climate change mitigation. Although the emphasis is on U.S. applications, relevant work from outside of the United States will also be considered. Top priority will be given to papers that incorporate well-conceptualized empirical applications, such as quasi-experimental or experimental economic methods, that will result in broader impacts through its effects on society.

Abstract Submission Guidelines

Authors wishing to have a paper considered for the NAREA Workshop should submit an extended abstract by Friday, February 14, 2014. Abstracts may be submitted online at www.narea.org/2014/ and/or via email to the Wesley Burnett, the Workshop Chair (e-mail to wesley.burnett@mail.wvu. edu). Abstracts may be e-mailed at any time prior to February 14.

The abstract file (MS Word or pdf) should contain the following information:
Cover page with:

- title of paper;
- name, address, e-mail address and phone number of paper presenter or primary contact;
- name and institutional affiliation of paper presenter and co-author(s); and
- 4-6 key words.

Separate pages with:

- title of paper; and
- extended abstract (1000 to 1500 words maximum; title and any references cited are in addition to this word limit).

Abstracts that do not comply with these guidelines will be returned without review. Electronic acknowledgements of submissions will be sent to all submitters. Abstracts will be reviewed by the NAREA Workshop Selected Papers Committee in terms of the significance to the field, strength of methodology/design, and clarity of writing. Authors will be notified of the status of their abstract by March 31, 2014.

Selected paper presentations will be 30 minutes. Full papers must be received from notified authors by May 16, 2014, to be included in the workshop's program. ARER must receive final papers by July 15, 2014, to be considered for expedited review in the special issue of ARER.

Obituaries



Professor of Agricultural Economics, Emeritus; Davis; 1923-2013

Professor Benjamin (Ben) French, 90, professor emeritus of agricultural economics at the University of

California, Davis, died August 23, 2013 at his home in Davis, California. Born May 30, 1923, in Hanford, California, Ben attended elementary schools in the Sacramento-San Joaquin Delta region of Northern California and graduated from Rio Vista High School in 1941. He developed a passion for duck hunting and fishing in his formative years and his love of the outdoors remained strong throughout his life.

Ben enrolled at UC Berkeley in 1942, but was soon called to active military duty in March 1943. As a paratrooper in the 82nd Airborne Division he saw active duty in both France and Germany. After the war, he reenrolled under the GI Bill, earning BS (1948), MS (1949), and PhD (1953) degrees in agricultural economics at UC Berkeley.

Professor French joined the faculty at Michigan State University in 1953 as an Assistant Professor in Agricultural Economics. He returned to the University of California's Davis campus in 1959 as an Associate Professor in the Agricultural Economics Department where he would establish a distinguished career in agricultural marketing.

He retired from UC Davis in 1989. During his early career Professor French extended the topics of economic efficiency in plant operations, covered in his award winning PhD dissertation, with a landmark Hilgardia monograph coauthored with Sammet and Bressler. This early research fostered a professional line of inquiry in Agricultural Economics that was well documented in his review article in Survey of Agricultural Economics Literature, Volume 1. Subsequent work in several topical areas was characterized by his attention to detail, depth of analysis, innovative approach and the application of applied econometrics to market policy questions. Significant contributions include supply response models examining market control programs for perennial crops including apples, pears, lemons, cling peaches, Brussels sprouts, asparagus and raisins. He also contributed to industry economic models for processing tomatoes, honey and eggs in addition to the literature on price bargaining for agricultural commodities. Professor French's pioneering research received numerous awards and recognitions. In 1981, he was selected as a Fellow of the American Agricultural Economics Association, its highest recognition.

Professor French's teaching contributions at both the undergraduate and graduate levels were noted for his thoughtful and rigorous development of the subject matter. He worked closely with his students and many now hold prominent positions in

universities, businesses and government. Professor French also made significant program contributions to development of the Department of Agricultural Economics at UC Davis, where he served for several years as Vice Chairman and then as the first Chairman when the Department became administratively separate from UC Berkeley in March of 1966. He served a full term as Department Chairman from 1976 to 1981. His insistence that the new Department meet the highest standards of scholarship greatly influenced its future development.

Professor French was widely respected by colleagues across campus for the rigor he insisted on in the newly revised teaching programs emerging in the College of Agriculture at Davis in the period 1964-68. His wisdom and commitment to what he saw as the required high standards of The University of California was particularly appreciated by Campus administrators for many years.

Three weeks after Ben's death, his wife of 65 years, Mary (Loscutoff) French, also passed away. Ben and Mary are survived by their daughter Susan French Weeks; sons Ben and Stan; son-in-law Ed Weeks; daughter-in-law Wendy Chan French; granddaughters Aubree French and Gillian Weeks; and great-granddaughter Bristol Bullivant.

Sylvia Lane (1916 – 2013) was the first woman to be named a Fellow of the AAEA (1984) and one of the

first women to be a tenured full professor in the agricultural economics profession. She has ation to countless students at UC Davis Berkeley and

been an inspiration to countless students and colleagues at UC Davis, Berkeley and beyond. She was a primary party to initiating the Committee on Women in Agricultural Economics (CWAE – 1981). Sylvia Lane died of natural causes October 15, 2013 in San Mateo, CA. Sylvia was born on May 26, 1916 in New York City, NY and moved to California at the age of 10. She attended UCLA and UC Berkeley and received her AB degree in Economics in 1934. At eighteen, Sylvia was one of the youngest women ever to graduate from Berkeley with a Bachelor's Degree. She received her MA in Economics in 1936 from Berkeley and performed additional graduate studies at Columbia University in 1937. Sylvia returned to Los Angeles to teach economics and met and married Benjamin Lane in 1939.

Sylvia taught Economics at McClellan Air Force Base in Sacramento and obtained her pilot's license during World War II. After

the war, she returned to Los Angeles and was a lecturer, then an assistant professor at the University of Southern California from 1947-1960 and received her PhD from the University of Southern California in 1957. She held the positions of Associate Professor of Economics, San Diego State University (1961-1965), Professor of Finance at California State Fullerton (1965-1969) and Chairperson of Department (1967-1969). She was a tenured Professor of Agriculture Economics at UC Davis (1969-82). Sylvia was the first consumer economist and tenured female faculty member appointed in that Department and one of the only women in the Agricultural Economics profession at the time. While at UC Davis she was one of the pioneers in the economics of nutrition and the household and through out her academic career, she was consistently focused on consumer interests and had a genuine concern for consumer welfare. She was an active Professor Emerita and economist at Giannini Foundation, at UC Berkeley after retiring from UC Davis. Over the course of her career, her research interests included consumer credit, consumer class actions, health care and rural health service delivery, housing, tax incidence, elderly needs assessment, low income nutrition and food stamps.

One of her noteworthy accomplishments was helping to draft the Food Stamps Program for the U.S. Department of Agriculture. In addition, she performed work for the World Health Organization (WHO) in Egypt. She was instrumental in advancing the careers of women in Agricultural

Economics, mentoring numerous graduate students at Berkeley even after she retired. She was on the executive board of AAEA (1972-1974), a member of the American Economics Association, American Council of Consumer Interests, the Omicron Delta Epsilon Society (President 1973-1975, Trustee 1975-83, and Chairman Board of Trustees 1982-1984). Sylvia's legacy is clearly in the success of her mentees as so many of them have made major advances in food in nutrition in the U.S. and abroad. Sylvia's advice to her mentees was "Choose your goals carefully".

A memorial celebration of Sylvia's life will be held November 17, 2013, 2pm - 4pm at UC Berkeley Women's Faculty Club. Obituaries

John Blair Riley

RILEY, JOHN BLAIR - died September 16, 2013. He was 66. He is survived by a sister and brother in law, Linda and David Hickey of Staunton, VA; and by a brother and sister-in-law, Doug and Donna Riley also of Staunton. He is also survived by nephews, Matthew Hickey and his wife, Stacie, and Jonathan Riley and his wife, Sandra. Other survivors include a niece, Rosalea Potter and her husband, Chas; as well as three great nephews, Benjamin and Bryson Riley, Scott Hickey; and special friend, Mrs. Fritzie Logan. John also had a beloved cat named "Peebles" who had been his constant companion for twelve years. He was preceded in death by his parents, J. W. and Edith Riley; and nephew, William Scott Hickey.

Following academic degrees at Virginia Tech and Oklahoma State University, Dr. Riley began his professional career as a professor in agricultural economics at Kansas State University in Manhattan, KS. While at Kansas State University he also served as acting head of the department and became the assistant director of Resident Instruction for the College of Agriculture.

In 1995, he became the Dean of the College of Agricultural Sciences and Natural Resources at University of Tennessee in Knoxville, Tennessee. He later returned to what he enjoyed the most-the teaching and advising of students. He was currently a professor in the Department of Agricultural Economics at University of Tennessee (UT).

Dr. Riley was very active in 4-H as a youth. He showed sheep and steers and took neighbors' flocks of sheep to county fairs as his way of raising money for his

college education. Numerous county leadership awards came his way, including being named a 4-H All Star. He continued to support 4-H and FFA activities throughout his life and received Honorary State Farmer's Degrees from both Kansas and Tennessee. His work with college students took many forms. He was advisor to the FarmHouse Fraternity at both Kansas and Tennessee. He coached the National AgriMarketing Association (NAMA) Marketing Teams at both Kansas and Tennessee and served as a team coach longer than any other university's team coach. His teams won several national competitions, but were always considered a team that you had to beat if you were going to win. He won the NAMA Outstanding Advisor Award while at both universities. For his work with the National NAMA Careers Committee, he was the only university person to be recognized by NAMA with its National Leadership Award. He was also advisor to departmental clubs but it was his contact with students as an academic adviser that was his true calling. John spent many hours, at any hour of the day or night, with students who needed his assistance. His advising efforts were recognized with several college and university awards. His classroom teaching was also recognized. For both his teaching and advising, he received the UT Institute of Agriculture's Lidvall Award. John provided leadership to numerous organizations. In Kansas, he chaired the local county Extension Council and provided leadership to the Kansas Junior Livestock Exposition. He chaired the university's board for the management of its cultural arts center and was the co-director of the

university's first all University Careers Fair. At UT he was president of the Faculty Club. At both universities, he served as president of the Phi Kappa Phi all university honor society and held officer positions in the agriculture honor society of Gamma Sigma Delta. He also served both honor societies at the national level. He was International President of Gamma Sigma Delta and served for 10 years as International Secretary. He was always active in his church, especially the choir, and was known for the cinnamon rolls he would occasionally make for a Sunday morning. John enjoyed the theatre, the opera, music, and cooking. He also spent much time helping care for his older neighbors and friends wherever he resided.

Funeral services were held at 1:00 pm on Sunday, September 23, at Lake Hills Presbyterian Church, 3805 Maloney Road, Knoxville, TN 37920 with Rev. James McTyre officiating. The family received friends after the service at the church. Funeral services were held at 2:00 pm on Monday, September 24, at Hebron Presbyterian Church, 423 Hebron Road, Staunton, VA 24401. Interment followed in the church cemetery. Members of the FarmHouse Fraternity served as pallbearers.
